## PURPOSE

Under the direction of the Chief Medical Officer, administers and accepts responsibility for planning, delivery, and documentation of comprehensive medical care of patients.

## **ESSENTIAL FUNCTIONS**

- Performs treatment of primary care and urgent care patients within the scope of license.
- Coordinates patient care with CMO and/or other providers. Revies care with CMO as required by license.
- Maintains availability for on-call duties.
- Supervises and instructs nursing personnel.
- Maintains knowledge of contemporary medical practices through continuing education.
- Attends meetings as requested.
- Participates in chart reviews for quality assurance.
- Participates in the planning, development, implementation, and support of policies and procedures, to continually improve the quality of patient care.
- Actively participates in budget, cost containment, and productivity efforts.
- Performs other duties as assigned.

### MINIMUM QUALIFICATIONS

- Demonstrated competency, education, training, and experience in provision of primary care services
- Demonstrated ability to effectively communicate with all levels of personnel and the public
- Demonstrated ability to effectively communicate with patients, orally and in writing
- Maintain ACLS (Advanced Cardiac Life Support) and PALS certification
- Maintain F-NP certification and current Arizona license
- Maintain all criteria of the DSCHC and contracted health plan credentialing process

## WORKING CONDITIONS/PHYSICAL REQUIREMENTS

- Air-conditioned office/treatment rooms
- Daily patient exposure to communicable diseases, blood and/or blood products
- Light lifting, considerable standing and walking
